<u>19/00365/HOU</u>	<u>Corners Chequers Lane</u>	Erection of a two storey side extension following demolition of existing garage. Window lengths to be reduced and windows replaced to the south elevation, and new replacement windows throughout. New porch roof, new garage and entrance driveway.
<u>19/00234/HOU</u>	<u>24 Kingsley Road</u>	Two storey rear extension with internal alterations following demotion of rear extension.
